The "Club Enhancement Levy" of \$250.00 per family is replacing the Working Bee Levy. This will be held by the club in 'trust' and returned to families after completing a minimum of 12 hours at any of the below activities throughout the year (July 2019 => June 2020)

In the past years total membership fees collected are less than the annual instructor's salaries for the year.
